IN ORDER TO SECURE YOUR CHILD'S ENROLLMENT FOR THE 2012-13 SCHOOL YEAR, A \$200 ENROLLMENT RESERVATION FEE IS DUE AT THE TIME OF ENROLLMENT. THE ENROLLMENT RESERVATION FEE IS A NON-REFUNDABLE FEE THAT IS APPLIED TO YOUR CHILD'S LAST TUITION PAYMENT OF THE SCHOOL YEAR. ANNUAL PAYMENT OPTION: THE FULL TUITION AMOUNT, LESS THE \$200 ENROLLMENT RESERVATION FEE, WILL BE CHARGED TO YOUR TUITION EXPRESS™ ACCOUNT ON SEPTEMBER 1, 2012.
